

## **IMPORTANT - READ BEFORE ACTIVATING THE SOFTWARE**

### **SOFTWARE LICENSE AGREEMENT FOR SSI SOFTWARE**

*The Software includes product activation designed to prevent unauthorized use and copying. This technology may cause your computer to automatically connect to the Internet and may prevent uses of the Software that are not permitted. Do not activate the Software provided under this license agreement ("Agreement"), until you have carefully read this Agreement. By activating the Software, using the activation code provided, you agree to be bound by the terms and conditions of this Agreement. If you do not agree to the terms and conditions of this Agreement, do not activate the Software. The effective date for this Agreement shall be the day you activate the licensed Software. You may have another agreement with SSI that supplements or supersedes all or portions of this Agreement.*

('SSI') grants to licensee the non-exclusive, non-transferable right to download, install, use, or otherwise benefit from the functionality or intellectual property of the copyrighted Software only in accordance with the terms of this Agreement. This license will continue for the specified duration or in perpetuity unless you violate the terms below or destroy all your copies of the Software. You may not sell, rent, or lease this license. The term 'Software' includes all computer code, activation codes and other materials, including any updates and upgrade thereto, that are provided to you under this Agreement .

### **SCOPE AND DURATION**

The scope and duration (time period) of your license depends on the type of license you obtained from SSI, as specified in the accompanying invoice. The variety of license types are set forth below. For more information on the types of licenses, please contact SSI.

#### **I SINGLE-USER SOFTWARE LICENSE**

If you are using the Software under the control of a Single-User license, you as an individual may install, activate, and use the Software on only one computer. A separate license is required for each additional use and/or individual user. SSI will provide you with an activation code that enables the Software for a Single-User license. If you obtained a time-limited Single-User license, the duration (time period) of your license and your ability to use the Software is limited to the time period of the obtained license (as specified in the accompanying invoice), which is controlled by the activation code for the Software. If you are an entity, SSI grants you the right to designate one individual within your organization to have the sole right to use the Software in the manner provided above.

#### **II CONCURRENT-USER SOFTWARE LICENSE**

If you are using the Software under the control of a Concurrent-User license, you may (a) install the Software on an unlimited number of computers that are connected to the designated network within your organization, provided that network has technology deployed to control the number of concurrent (or simultaneous) users, and (b) use the Software by no more than the authorized number of concurrent users (as specified in the accompanying invoice). A separate license is required for each additional concurrent user and/or network on which the Software is used. SSI will provide you with an activation code that enables the Software to be used on each computer.

Except as expressly provided herein, no license or right is granted to you directly or by implication, inducement, estoppel, or otherwise, specifically SSI does not grant any express or implied right to you under SSI patents, copyrights, trademarks, or trade secret information. You may not reverse engineer, disassemble, decompile, or otherwise attempt to discover the source code of the Software.

SSI agrees to respond in writing (by email) to brief technical questions from Registered licensee only.

The Software is guaranteed to replicate output generated from sample files provided with the Software.

SSI reserves the right to determine if and/or when an error in Software coding exists, as well as when, how, and whether you will be sent a refund or a free correction. SSI warrants that the Software does not infringe any patent, trademark, trade secret, copyright, or other proprietary right of any other person or entity.
